Financial Incentive to Indigenous and Tribal Performing Artists.

2021-22

- 1. Objective of the Scheme:** The main objective of the Scheme is to support and promote traditional art and culture of the indigenous and tribal people of MAC area by giving financial incentive to performing artists of these communities.
- 2. Category of performing artists for which incentive will be given:**
 - a. Folk singers
 - b. Folk dancers
 - c. Folk instrumentalists
 - d. actor
 - e. Director
 - f. Puppetry
 - g. Any other performing artists
- 3. Eligibility:**
 - a. The applicant must be a resident of MAC area.
 - b. He/she must have performed at district, state or national level shows.
 - c. He/she must have his/her own production
- 4. Amount of incentive:**
 - a. This is a one-time incentive as follows:
 - i. Rs. 10000.00 (Rupees Ten Thousand) for up-coming youth artists at District level
 - ii. Rs. 25000.00 for renowned legendary artists performing at state/national level.
 - b. Poorer among the applicants will be given priority.
- 5. Disbursement:**
 - a. The amount shall be credited directly by MAC to the Applicant's Bank Account through Electronic Clearing Service (ECS)/ Credit Clearing Mechanism (CCM).
 - b. The applicant must fill up ECS Form giving bank details and certified by the concerned bank.

6. Procedure for award of Assistance: The award of assistance will be regulated as under:

- a. **Application:** Applicants, aspiring for the assistance, shall download the Application Form from the MAC's Website or collect from the Office of the MAC. Application form along with the relevant documents as per check list received on or before last date of submission shall only be accepted for evaluation.
- b. **Selection:** Selection shall be made by an apex level Committee constituted by the Executive Council of MAC. The short listed artists shall be given a citation at a ceremonial function along with electronic transfer of the incentive. The final list of beneficiaries shall be uploaded on MAC website i.e. www.macassam.nic.in

7. Other Terms and Conditions:

- a. MAC reserves the right to alter, modify, interpret or withdraw the assistance scheme as considered necessary without any notice.
- b. The assistance is for folk artists from any community of MAC areas.
- c. Decision of MAC with regard to selection will be final.
- d. Applications not in the prescribed format or received after the last date of submission of Application Form or not accompanied by supporting documents are liable to be rejected.

8. HOW TO APPLY

- a. The candidates fulfilling the above eligibility criteria may download the Application Form from www.macassam.nic.in and submit their application form to the Office of the Principal Secretary, Mising Autonomous Council.
- b. Complete application with all the supporting documents as mentioned in the application form duly certified and verified by appropriate authority should reach the office of MAC as per the details given in the application format.
